I'm definitely looking forward to the next growing season to enjoy the new habitat that will be getting established across the southwest part of the state.

Outreach Opportunities

This quarter, I hosted four workshops in my coverage area about pollinators. These workshops covered the habitat needs and importance of pollinators, honey bees, and monarch butterflies. Additionally, I talked about financial assistance programs, such as EQIP and RCPP, that are currently available to help fund projects that create pollinator and monarch habitat. These events had great turnouts with over 60 attendees total. I was able to partner with Iowa State University Extension and Outreach for these workshops which was definitely value added for not only the partners but also the attendees.

I also presented at the Women Gaining Ground Conference this quarter. Topics that I covered included the importance of pollinators, their habitat requirements and how to establish and maintain pollinator and monarch habitat. A key point I talked about was that regardless of the size, backyard gardens to large acre fields, every bit of habitat can be beneficial to pollinators.
